4. Public Participation:

- Burnham Thorpe WhatsApp Group could parish council meetings be advertised on Burnham Thorpe WhatsApp to alert people.
- Parish Website for Burnham Thorpe https://burnham-thorpe.parish.uk/: This is not the Parish Council website but is a website provided by Community Action with details of the parish. It is not a government website but uses data in the public domain for information for that parish. Every parish in Norfolk has a Parish UK website however most are outdated.
- Pedestrians walking between Back Lane and Mill Lane to footpath –This is very dangerous because of the narrow road. There is no village entry sign along this road.

5. Reports:

- a) Borough Councillor Report: None
- b) County Councillor Report: None.
- c) Clerks Report: Streetlight Westcotec had been chased to instal the streetlight, Dog bin waiting to be placed near black bin on Lowes Lane but waiting on Borough Council, Public Right of Way opposite Church has been reported to be cut, benches on Millennium Piece need to be removed as soon as possible.

6. Finances:

- a) Financial Statement for July 2025: Bank reconciliation been completed. Budget Comparison discussed. Approved.

- c) Parish Partnership Grant: Letter circulated for Parish Partnership Grant for highways infrastructure. Deadline 1st December. Clerk to write to Highway Engineer regarding the road between Back Lane and footpath on Mill Lane. Clerk to enquire if he can have a site visit with Councillors. Clerk to check whether Village Name Sign could be placed along Mill Lane to alert drivers of entering a village and whether this was possible under Parish Partnership.
- d) Termination of Nurture Contract: The contract had been terminated and awaiting for invoices to come through. Heronwood were now undertaking the cutting of the playing field.
- e) K&M Lighting Contract: This was agreed to undertake the contract for a year at the cost of £67.90 plus VAT.
- f) Local Government Services Pay Agreement: Clerks wages were on SCP 18 at £15.84 per hour. This was now increasing to £16.35 per hour and being back dated to 1st April. This was approved.
- g) Seminar October with Norfolk Parish Training: Clerk to attend Seminar at a cost of £22.40. This was approved.

7. Old Railway Line

At present 15 evidence forms have been completed. It was agreed to wait until 1st October for any further evidence forms to be submitted. After this date the Clerk can send them off with Notices to Norfolk County Council.

8. Village Map

Cllr M Garland had explained that the contractor who completed the maps for Holkham did not complete the artwork. Cllr Garland to contact Holkham Estate to enquire as to who completed the artwork for them.
